LYON COUNTY BOARD OF COMMISSIONERS

Tuesday, January 7, 2025

A Summary of the Proceedings of the Lyon County Board 9:00 a.m. pursuant to notice the Lyon County Commissioners met with the following members present: Commissioners Anderson, Andries, Crowley, Draper, and Graupmann. Also present: Administrator Stomberg and County Attorney Wikelius.

- MSP to nominate Gary Crowley as chairman for 2025.
- MSP to nominate Todd Draper as vice-chairman for 2025.
- MSP to approve agenda with the addition.
- MSP to approve consent agenda as presented.
- MSP to approve contract amendment no. 4, pending that SWHHS board also approves, for an additional 1,200 sq. foot of office space.
- MSP to approve the out of state travel policy.
- MSP to approve www.lyonco.org home page as the official publication for advertisement towards transportation related projects for 2025.
- MSP to approve the micro-purchase threshold of \$20,000 to be uniform for the guidance to meet the Auditor/Treasurer's requirements.

- MSP to approve the addition of prescription drug costs to the Auditor Treasurer's pay of certain claims.
- MSP to approve the resolution for Designation of Depositories.
- MSP to approve the resolution to transfer funds for drainage systems.
- MSP to accept the donation from Julie Nilson, and place into the new donation account.
- MSP to approve Lyon County as the fiscal sponsor for the City of Minneota, with the condition that the City of Minneota be solely responsible for the 20% match per vehicle they purchase.
- MSP to approve the resolution for Lyon County to sponsor and support the application for Safe Routes to School Grant by the City of Tracy.
- MSP to approve the resolution for Lyon County to sponsor and support the application for MN Active Transportation Grant by the City of Tracy.
